Soundings in St Lawrence River are referred to the sloping surface of the river when Lake Ontario is at elevation 243.3 feet / 74.2 meters above Mean Water Level at Rimouski, Quebec, the International Great Lakes Datum 1985 (IGLD 1985) reference point.

## VERTICAL DATUM

Overhead clearances in the Great Lakes are reduced correspondingly when water surface is above Low Water Datum. See U.S. Coast Pilot 6 for clearances.

## RADAR REFLECTORS

## SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. Vessels operating in fresh water lakes or rivers shall not discharge sewage, or ballast, or bilge water within such areas adjacent to domestic water intakes as are designated by the Commissioner of Food and Drugs (21 CFR 1250.93). Consult U.S. Coast Pilot 6 for important supplemental information

## CAUTION

Due to periodic high water conditions, in the Great Lakes, some features charted as visible at Low Water Datum may be submerged, particularly in the near shore areas. Mariners should proceed with caution.

## SEAWAY NOTES

The improved channels and canals in the deep waterway between the Port of Montreal and Lake Erie are designed for a controlling depth of 27 feet / 8.2 meters.

The loaded draft and speed of vessels in any part of the deep waterway shall be controlled by the Master according to the vessel's individual characteristics, and its tendency to list or squat, so as not to strike bottom.

In the Seaway canals the maximum permitted draft will be currently prescribed by the St. Lawrence Seaway Development Corporation and the St. Lawrence Seaway Management Corporation.

## NOAA WEATHER RADIO BROADCASTS

The NOAA Weather Radio station listed below provides continuous weather broadcasts. The reception range is typically 20 to 40 nautical miles from the antenna site, but can be as much as 100 nautical miles for stations at high elevations.

## NOTE Z NO-DISCHARGE ZONE, 40 CFR 140

Under the Clean Water Act, Section 312, all vessels operating within a No-Discharge Zone (NDZ) are completely prohibited from discharging any sewage, treated or untreated, into the waters. Commercial vessel sewage shall include graywater. All vessels with an installed marine sanitation device (MSD) that are navigating, moored, anchored, or docked within a NDZ must have the MSD disabled to prevent the overboard discharge of sewage (treated or untreated) or install a holding tank Regulations for the NDZ are contained in the U.S. Coast Additional Pilot. information concerning the regulations and requirements may be obtained from the Environmental Protection Agency (EPA) website: https://www.epa.gov/vesselsmarinas-and-ports .
